### annual report highlights achievements

As the end of the year approaches, I want to extend Season's Greetings from everyone at the Nebraska Lottery.

The end of our 15th Anniversary year is a perfect time to reflect on our accomplishments and look forward to the possibilities to come. Recently, the Nebraska Lottery published our 2008 Annual Report and Resource Guide (for the fiscal year that began on July 1, 2007, and ended on June 30, 2008), and I'd like to share a few highlights from the publication that may be of interest to our retail partners.

Sales of all Nebraska Lottery games (Scratch and Lotto) for the fiscal year totaled more than \$121 million. Total contributions to Nebraska Lottery beneficiary funds passed \$319 million with the June quarterly transfer. During the fiscal year, Nebraska Lottery beneficiary funds received a total of \$31 million.

There were several changes to the Nebraska Lottery's Lotto offerings during the fiscal year. In February 2008, enhancements were introduced to the 2by2 game by the Multi-state Lottery Association. Sales of 2by2 increased 7.16 percent over the previous fiscal year. Additionally, plans were finalized during the course of the fiscal year for the October launch of MyDaY, and improvements to Powerball were announced after nearly a year of discussion and research by the members of the Multi-state Lottery Association.

Nebraska Lottery retailers received more than \$7 million in commissions during the fiscal year.

Nebraska Lottery research found that 44 percent of the eligible population (age 19 or older) has played a Nebraska Lottery game in the past year.

During the fiscal year, visits to nelottery.com grew by 13 percent to more than 2.8 million.

Beyond these highlights, the 2008 Annual Report and Resource Guide contains information about developments in Scratch and Lotto games, special contests and promotions, and major winners claimed at Nebraska Lottery claim centers. (continued on back)

# 2by2 tuesday ethanol fuel promotion

# Lincoln Woman Wins \$5,000 MyDaY Top Prize

Jenny Schroeder of Lincoln recently won \$5,000 playing MyDaY from the Nebraska Lottery.

There were more than 17,000 Nebraska Lottery winners in the Wednesday, October 22, drawings. Among these winners was Schroeder, who purchased a five-play MyDaY ticket at Handy Shop, 1700 L Street

in Lincoln. One quick-pick play matched the winning Month

(5), winning Day (6), and winning Year (55) from the October 22 drawing for a corresponding prize of \$5,000.

Schroeder wasted no time in claiming her prize, arriving at Nebraska Lottery headquarters the day following the drawing. She stated that she regularly purchased five-play MyDaY tickets to be eligible for the Make MyDaY Bonus Raffle promotion, using her birthday for one play and quick-picks for the remaining four plays. Schroeder learned she had won the \$5,000 prize after calling the Nebraska Lottery Player's Hotline (800-224-LUCK). She plans to pay bills and pay for car repairs using her winnings. The odds of winning the \$5,000 top prize in MyDaY are 1 in 36,525, while the overall odds of winning any prize are 1 in 8.17.

## Lexington Man Wins \$20,000 Deal or No Deal Prize

Timothy Wear of Lexington won \$20,000 playing the \$3 Scratch game Deal or No Deal from the Nebraska Lottery.

Wear purchased his winning Deal or No Deal ticket at Mac's Short Stop, 1114 North Adams in Lexington. After scratching the 20 briefcases in the play area, Wear matched the revealed dollar amounts to the cash prizes in the ticket prize board. A single \$20,000 prize remained. There are two \$20,000 top prizes available in Deal or No Deal. Wear is the first person to claim a top prize in this edition of the game.

Based on the popular NBC game show, the \$3 Deal or No Deal Scratch game offers players the chance to win \$979,225 in total cash prizes from \$3 to \$20,000. The odds of winning \$20,000 playing Deal or No Deal are 1 in 240,000, while the overall odds are 1 in 3.52.

# game closing procedure

Recent developments at other lotteries regarding closed Scratch games have prompted some changes in the Nebraska Lottery's game closing procedures. These changes are designed to keep our retailers and players informed about the availability of Nebraska Lottery Scratch games.

When a game begins the closing process, a message is sent to every Nebraska Lottery terminal informing retailers that the game is closing. This is the official notice of the close of the game. When you receive this terminal message, please remove any packs of the closed game from your display unit and store them in a secure location.

Lottery Sales Representatives will pick up remaining partial or full packs of closed games during their next call cycle. Your LSR can provide special envelopes to hold these packs. We encourage retailers to use these envelopes to secure closed game packs until they are picked up.

Retailers are then notified in writing that a game is closing via a printed insert which is included with new ticket shipments. The insert lists the closing date and the last day tickets can be redeemed. Game closing information is also posted on the Nebraska Lottery web site, along with weekly updates on prizes remaining information.

By following these procedures, our players can have the best experience possible when purchasing their favorite Scratch games. Contact your LSR if you have any questions.



Did you know that you can request credit for a Lotto ticket that was generated in error? Follow these steps to receive credit:

- If possible, sell the ticket to another customer. A "Lucky Mistake" ticket can often be sold quickly if you make it fun to purchase. Your LSR can provide a Lucky Mistake Ticket sign if needed.
- 2. If you are unable to sell the ticket and draw break is nearing, call the Lottery Retailer Hotline (800-352-6510). Press 1 to request credit.
- 3. Make a note on the ticket with the date that credit was requested for your reference. Watch for the credit (less commission) on your Lotto Adjustment Report.
