# **New for 2010**

The New Year has started, and I want to extend best wishes to everyone on behalf of us at the Nebraska

Lottery. There are a number of exciting things planned in 2010, and I'd like to note some of them here.

The multi-state Mega Millions® lotto game is coming to Nebraska in March. Mega Millions is similar to Powerball in that both games feature large jackpot prizes, but in the past the games have been sold in separate jurisdictions. An agreement in October 2009 between the Multi-state Lottery Association (MUSL), which operates the Powerball® game, and Mega Millions member lotteries provided the opportunity for lotteries to offer both games. Mega Millions is drawn on Tuesday and Friday nights, and we feel our customers will appreciate having two more chances a week to win a jackpot prize.

The Nebraska Pick 5 Jackpot Doubler promotion returns on February 1. The Doubler promotion is a player favorite, and last year five double jackpots were won during the month of February. Also coming back for 2010 is the Power Play 10X promotion, which will occur in May.

On the Scratch side, we have several new products that will be appearing in your stores soon. Scratch game turnover is always high after the holidays, as our holiday games sell out and other games take their places. Additionally, a newspaper coupon insert was recently distributed in weekly newspapers across Nebraska along with an in-store coupon. We expect that these coupon offers will help to maintain sales in the first quarter of the year.

In partnership with over 1,200 Nebraska Lottery retailers, we will continue to fulfill our mission of supporting good causes in our state in 2010. To recognize the efforts of our retail partners, a listing of top retailers from Fiscal Year 2008-2009 can be found on the back of this issue of Ticket Talk. The Nebraska Lottery truly appreciates the support of our lottery retailers, and together we are truly Helping to Build a Better Nebraska.



# **Nebraska Pick 5 Jackpot Doubler**

Back by popular demand, the Nebraska Pick 5 Jackpot Doubler promotion begins on February 1, 2010.

The Jackpot Doubler promotion doubles the Nebraska Pick 5 jackpot each time it is won during the month of February. If a player correctly picks all 5 out of 5 numbers for a draw during the promotion, the winner would receive double the amount of the advertised jackpot. For example, if the advertised jackpot is \$90,000 and all five numbers for that draw are correctly chosen, the winner would be entitled to \$180,000.

Though the 'doubler' aspect of the promotion only applies to the jackpot amount, the promotion will continue to apply to all drawings throughout the month regardless of how many times the jackpot is won. If a Nebraska Pick 5 jackpot is never won during the month of February, then the first jackpot won after February will double. For example, if no jackpot is won in February, but a Nebraska Pick 5 jackpot is next won on March 5, 2010, that jackpot will be doubled

## **Nebraska Lottery Retailer Advisory Board**

The Nebraska Lottery utilizes the opinions of the advisory board in making decisions on promotions, advertising,
POS, equipment, and other related issues.

Board members work for or own businesses that are Lottery retailers and come from a variety of retail types including convenience stores,



grocery stores, liquor stores, and other businesses. Board members may be involved with only one store/location or they may supervise/own numerous locations. We try to have a balance of members from varying business types and locations throughout the state

Retailer Advisory Board meetings are held quarterly; currently in May, August, November, and February in Lincoln. Members receive mileage reimbursement, but otherwise are not paid.

Nominations for board membership are made to the Nebraska Lottery Key Accounts Manager, then forwarded to the Nebraska Lottery Director for appointment. Currently there are five board memberships open for nomination.

A new year signals a time for new beginnings and starting new routines. Here are some accounting tips and tricks from the Nebraska Lottery to start 2010 off right.

- To avoid confusion, do not return validated Scratch or Lotto tickets to players unless the ticket has not been paid. If you encounter a problem validating a ticket and have not paid, give both the receipt and the ticket back to the customer and instruct them to claim their prize at a Nebraska Lottery Claim
- If you have scanned a winning Scratch ticket and don't have enough cash on hand to pay, please call Lottery Accounting at 800-587-5200. Mark the back of the ticket as "not paid" along with your name and date. Give both the receipt and the ticket back to the customer and instruct them to claim their prize at a Nebraska Lottery Claim Center.
- If a communication error occurs on your Lotto terminal during a transaction, you can touch the "Utilities" button, then touch "Last Transaction" to check if the transaction was successfully completed and the value of the last validation.
- Activated, settled and returned Scratch ticket reports are available for one week after a new Weekly Settlement Report has printed.
- Prizes from closed Scratch games or expired Lotto tickets cannot be claimed at a Nebraska Lottery retailer or Claim Center. If a customer tries to redeem a ticket from a closed or expired ticket, remind them that prizes can be redeemed up to 180 days after the closing date (for Scratch tickets) or 180 days after the drawing date (for Lotto tickets). Prizes from these tickets cannot be claimed by mailing them to the Nebraska Lottery.
- If the three-digit box code on the front of a Scratch ticket is unreadable, instruct the player to mail the ticket to the Nebraska Lottery at the prize claim P.O. Box on the back of the ticket to claim their prize.



Starting in March, Nebraska Lottery players will be able to play Mega Millions, a multi-state jackpot game currently offered by 12 lotteries across the United States.

Each Mega Millions play costs \$1. The Mega Millions jackpot starts at \$12 million; other prizes in the game range from \$2 to \$250,000. Players who choose to add the \$1 Megaplier option have the chance to multiply their non-jackpot prizes as many as two, three, or four times. Drawings for Mega Millions are held every Tuesday and Friday, giving players four chances a week to win a multimillion dollar jackpot by purchasing both Powerball and Mega Millions.

More information about the launch of Mega Millions will be provided to retailers in the coming weeks.
