

A Record-Breaking Spring

ar saying that "records were made to be broken." This spring has seen some longstanding records broken for the Nebraska Lottery.

The enhanced Powerball game got off to a great start with a jackpot run that resulted in our first \$1 million Powerball winner. The \$336 million Powerball jackpot drove purchases of Nebraska Lottery tickets and set a new sales record of \$4.5 million for the week of Feb. 12. This record was shortlived, as another multi-state game stepped into the national spotlight.

March was quite a busy month for the Nebraska Lottery and the other lotteries that offer the Mega Millions game. I don't think anyone predicted that the jackpot would eventually reach a world record of \$640 million, sending players streaming into retailers to purchase tickets for the big draw. We understand that this recent jackpot run presented challenges for our retailers, and I want to thank you for your outstanding efforts.

While the historic jackpot was split by players in Kansas, Illinois, and Maryland, our state did get some significant benefits from the Mega Millions jackpot run. Ticket sales set a new weekly record, and retailer commissions and proceeds for our beneficiaries were significantly increased. \$50,000 Chocolate Prize for Columbus Woman

Calan Reppert of Columbus won \$50,000 playing the \$5 Scratch game Chocolate from the Nebraska Lottery.

Reppert purchased her winning Chocolate ticket at Cubby's, 1303 Tahazouka Drive in Norfolk. Scratching the ticket, she revealed matching numbers with a corresponding prize of \$50,000.

There are three \$50,000 top prizes in Chocolate. Reppert is the second person to claim a top prize in the game.

While claiming her prize on March 12, Reppert told Nebraska Lottery officials that this was the first time she had purchased a Scratch ticket. "I was shocked when I scratched it off," said Reppert. "It was unreal." She plans to start a college fund for her daughter using her winnings.

The odds of winning the \$50,000 top prize in Chocolate were 1 in 120,000, while the overall odds of winning any prize were 1 in 3.46.

\$40,000 Mega Millions[®] with Megaplier[®] Prize for Valley Man

Ronald Kellams of Valley recently won \$40,000 playing Mega Millions with Megaplier from the Nebraska Lottery.

There were more than 10,000 Nebraska Lottery winners in the Tuesday, March 20th drawings. Among these winners was Kellams, who purchased a three-play Mega Millions with Megaplier ticket at Quik Pik, 230 East Highway

275 in Valley. One play on the ticket contained four of the five winning white ball numbers (1, 4, 6, 11, 14) and the Mega Ball® number (30) for a \$10,000 prize.

Because Kellams added the \$1 Megaplier option to his purchase, his \$10,000 prize was multiplied by the 4X multiplier for \$40,000.

The odds of winning \$10,000 playing Mega Millions are 1 in 689,065. Adding the \$1 Megaplier option, which does not affect the odds of winning, gives players a chance at multiplying their non-jackpot prizes two, three, or four times.

Mega Jackpot Generates Mega Sales, Proceeds


At the end of March, lottery players across the country were lining up for a chance to win a record-setting Mega Millions jackpot.

A total of 18 consecutive drawings without a winner drove the Mega Millions jackpot to \$640 million for the March 30 drawing. This world record jackpot spurred sales of Nebraska Lottery tickets, as well as the sales of additional items players bought along with their tickets.


Total sales of all Nebraska Lottery games during the final week of the jackpot run set a new record of \$5.8 million. Lottery retailers also received over \$200,000 in commissions during the week. Mega Millions sales during the jackpot run, along with implementation of new Powerball features and strong Scratch sales, drove overall sales for the third quarter of the fiscal year to over \$44 million. These are figures to be proud of, and indicate the strong support the Nebraska Lottery receives from its retail partners.

Another figure of note was the \$10 million quarterly transfer to our beneficiary funds made at the end of March. This was the largest beneficiary transfer in the history of the Nebraska Lottery. Lottery proceeds benefit the environment, education, the Nebraska State Fair, and compulsive gambler's assistance. Over \$439 million has been raised for good causes across Nebraska since 1993.

Ticket Confirmation and Activation

As a reminder, please remember to confirm your tickets shipments when they arrive and activate packs before selling tickets.

Upon receipt of a package of tickets, verify that the shipment agrees with the Ticket Delivery Form, then immediately confirm the receipt of the order on the terminal by touching "Scratch Functions," selecting "Confirm," and scanning the packing slip barcode. This notifies us of the receipt of the delivery, and is a necessary step or the tickets can't be activated

Activation must take place before placing the tickets in the dispenser for sale. If an inactive ticket is sold and taken to another retailer, the player can't redeem their ticket. This ends with unhappy players, and clerks have to use their valuable time calling the hotline to correct the issue. Thank you for your assistance in following the steps necessary in this process.
